

# **Placement Description**

Placement Title: South Walney Student Placement

**Weekly Hours:** Flexible working, suggested 4 days (28 hours per week, mid-week with occasional

weekend or evening work)

**Commitment:** Sandwich year, maximum 10-month placement from June 2025 to April 2026

(start dates flexible). We allow flexible leave to be taken with notice and the placement duration may be shortened as long as placement requirements are

met

**Based At:** Based at Cumbria Wildlife Trust, South Walney Nature Reserve, Walney Island,

Barrown-in-funrness, LA14 3YQ with flexible home-working and frequent travel

to sites as part of the role is essential.

#### **Placement Purpose:**

As part of the Nature Recovery Directorate, you'll support the team of reserve staff in managing of South Walney and Foulney Island nature reserves in south-west Cumbria. This will involve hands-on practical work, including habitat management, habitat management and estate maintenance, habitat and species monitoring, working with volunteer groups and visitors, and supporting the production of site management plans, reports, and data analysis.

Key parts of the role involve supporting the monitoring and protection of breeding birds and the winter colony of grey seals and maintaining visitor infrastructure to help visitors experience the amazing wildlife.

#### **Special Features of the Role:**

Based on South Walney Nature Reserve, you'll be an important part of the small team helping to protect this internationally important landscape for breeding birds, including arctic terns, ringed plovers, oystercatchers and eiders.

There'll also be opportunities to support the Trust's work in the wider area on other nature reserves around the county. Develop practical skills to support and deliver important conservation works to enable nature's recovery. You'll gain skills and experience in habitat management whilst exploring and learning on a variety of sites from the remote to popular visitor areas.

As part of our student placement scheme, ongoing training will be given to carry out tasks including practical site management, species surveying, data analysis using GIS, and supporting volunteer activities. A full induction will be provided. The post holder will also have opportunities to gain experience supporting partners and other teams across the Trust.

Due to the nature of the role, an independent and self-reliant style of completing tasks is required. The opportunity will involve walking and undertaking practical work over rough upland terrain and uneven ground. **A full valid driving licence and access to a vehicle is essential** due to the remoteness of the sites. We offer flexible working from home or in our office based at Plumgarths. Applicants will

need to be able to travel across Cumbria, primarily in the south but further afield as opportunities arise. The Trust has a number of fleet vehicles available for use, but placements may occasionally be required to use their own vehicle for which mileage expenses will be paid.

A bursary package will be provided including a subsistence allowance totaling £7711 for the 10-month period (paid through monthly installments during your time with us) and an additional training budget of £1000.

The role at South Walney Nature Reserve is available with rented accommodation on site. Whilst only a few miles from Barrow-in-Furness, the site is remote and isolated.

As part of our placement scheme, you'll receive outdoor first aid training alongside career development skills training including interview, presentation and CV writing. Prior to your start date and throughout, we will support you and plan a personalised training schedule to ensure you gain the most from your time with us. We are offering a bursary as a gesture of goodwill as we recognise that an individual undertaking a student placement is not entitled to National Minimum Wage because it is work experience required as part of the higher education course. Travel and voluntary expenses will be covered.

### Main Responsibilities and Accountabilities:

**Habitat management and facilities maintenance:** Carry out practical habitat management works and site maintenance tasks. Assist with the management of contractors on site. Gain skills and experience supporting and managing our teams of volunteers. Ensure that all equipment, tools and vehicles are properly maintained and fit for purpose. Ensure that all records of maintenance checks are kept up to date and in accordance with Cumbria Wildlife Trust codes of practice. Ensure Health and Safety standards are met.

**Survey and monitoring**: Assist with systematic monitoring of nature reserves which could include bird surveys, butterfly transects and vegetation monitoring. There may be the opportunity to get involved in other Trust-wide initiatives such as marine and peatland surveys too.

**Staff and volunteer responsibilities:** Support the development of volunteers and help maintain effective volunteer groups across our reserves through supporting and supervising conservation days. Develop good working relationships with groups, communities, visitors and volunteers and work in compliance with our volunteer and equality and diversity policies.

**Administration:** Respond to telephone calls, e-mails and other enquiries. Support data input, reporting and creation of site management plans with support. Ensure all Cumbria Wildlife Trust documentation is completed.

**Team working:** Actively support and shadow the Nature Reserves team of 13 staff members. Work alongside other placement students, volunteers and wider Cumbria Wildlife Trust staff members.

Rented accommodation is available on-site at £320 pm, including all bills.

- **4. Place of work:** Cumbria Wildlife Trust's office at South Walney, Walney Island, Barrow in Furness, Cumbria, LA14 3YQ.
